To be eligible for the allowance, you must meet all the requirements below:

Agency Employee must be employed at a US based Public Authority Agency at the time of motorcycle delivery. A Public Authority Agency is considered to be a Federal, State or Local Police Agency / Authority, Sheriff's Department, FBI, DEA, NSA, US Border Patrol, Port Authority Police, US Coast Guard, etc.

Fleet purchases of police model BMW motors by the Public Authority do not qualify for this special incentive.

After the purchase, the Agency Employee sends this Special Allowance Check Request Form, copy of proof of purchase (bill of sale), copy of the motorcycle registration, and proof of agency employment to BMW Motorrad USA Sales Operations (Address: P.O. Box 1227 Westwood, NJ 07675-1227 - Attention: BMW Motorrad USA Sales Mgr). Once approved, the allowance check is mailed directly from BMW Motorrad USA to the purchasing Agency Employee.

Purchase Terms & Conditions:

Agency Employees are eligible for one Agency Employee Purchase allowance for personal use motorcycles purchased during the program period of October 14th through December 31st, 2007.

Motorcycles purchased and reported under a name other than the qualified Agency Employee do not qualify. Sales documentation, registration and title must be in the Agency Employee's name.

After the purchase, an Agency Employee Personal Purchase cannot be assigned to another Individual for 6 months.

This allowance may be combined with any other retail customer incentive available at the time of purchase for a qualified model, which is defined as any new, previously unregistered / unreported BMW motorcycles sold between the dates of October 14th – December 31st, 2007. Motorcycles must be purchased through an authorized BMW Motorrad USA dealer. Purchases through a 3rd party are not eligible.

Applications not submitted within 60 days of the date of delivery are not eligible for this allowance.

BMW Motorrad USA reserves the right to make changes to the Program and/or terminate the Program at any time without prior notice. All claims are subject to audit. In the event of improper reporting or other program-related improprieties, BMW Motorrad USA reserves the right to recover payment.
