## PROGRAM GUIDELINES:

### ELIGIBLE MODELS

All models must be new and unregistered (warranty and title) to qualify for the promotional rate and term. Units purchased at below dealer invoice are excluded from all retail finance promotions (i.e. special category product sales, law loan, government, Ride First, demo, rental, safety education, etc.), unless specifically allowed in Program Details. Offer good only on consumer retail sales.

### MAXIMUM LTV

Contracts may be written up to 125% of the manufacturer invoice, Tier 3 - 5 contracts may be written up to 115% of manufacturer invoice, PLUS tax, title, document fees, freight & setup, warranties and dealer installed accessories. The combination of backend products such as extended service plans, GAP, warranties, and soft good accessories can be financed up to 15% of the cash sale price of the unit. Up to \$400 max for doc prep fees. Up to \$2,200 max for freight & set up, additional \$200 max for freight & set up of the trailer. Contracts that include Yamaha Extended Service (Y.E.S.) may exceed the maximum financed amount by \$1500.
